

## **Academic Assessment Plan (MFA in Studio Art) (May 2024)**

*(Program goals are broad general statements of what the program intends to accomplish and describes what a student will be able to do after completing the program. The program goals are linked to the mission of the university and college.)*

**1. As the terminal degree in the field, the MFA program will cultivate achievement of the highest level of professional skill in the graduate student's area of study in visual arts and contemporary practices requiring:**

- a. A demonstrated formal and technical proficiency in the major studio area.**
- b. A demonstrated conceptual development supporting creative research.**
- c. An ability to locate the work within the context of contemporary and historical**

**issues in art (including references to other artists and art movements influential to the development of the work) and placing the research within visual culture.**

**d. An ability to successfully articulate the basis of research in written and verbal form.**

- 2. The program will ask students to rigorously deconstruct their practice encouraging risk-taking and experimentation towards the goal of expanding their practice and deepening their understanding of the implications of their work in the context of art history, critical theory, and visual culture.**
- 3. The program will prepare students to be contributors to an interdisciplinary art and design world as creative thinkers and inventive problem solvers who are conscientious of technological, social, physical and cultural contexts.**
- 4. The program will provide teaching and technical experience through Graduate Assistantship and Internship positions, which will make our students more marketable.**

### **Student Learning Outcomes**

*(Student Learning Outcomes are defined in terms of the knowledge, skills, and abilities that students will know and be able to do as a result of completing a program. These student learning outcomes are directly linked to the accomplishment of the program goals.)*

- 1. Students will evaluate their own methodology through active research, analysis, and interpretation of the contemporary art and design world as it relates to their own research to solidify a foundation for their studio practice.**
- 2. Students will demonstrate the ability to solve complex problems through art and design through requirements including the design and installation a solo exhibition of thesis work in their third year.**
- 3. Students will master technical processes specific to their concentration area and learn new skills towards an interdisciplinary practice.**

4. Students will develop the ability to be successful collaborators using strong communication skills.
5. Students will demonstrate the ability to be lateral thinkers through experimentation and exploration during concept development.
6. Students will identify and describe historical precedents and contemporary practices as they relate to various cultures and critical theory in the justification of formal, technical and conceptual decisions.
7. Students will learn the teaching and technical skills needed to apply for university-level teaching positions and other related career positions.

### **Process for Assessing each Student Learning Outcome**

1. **Timeline for assessment and analysis**
  1. **Direct Methods** are assessed by the MFA coordinators of the Department of Art at the end of every semester in which an Academic Progress form is filled out and sent to the Graduate School. In-Direct methods are monitored by Chair, Dean, Provost through the Annual Report and the fields of study through external achievements of students continuing in the studio art and design fields.

The Annual report is submitted annually in July.
2. **Means of assessment and desired level of student achievement.** *(Must include at least one direct and one indirect method of assessment for each learning outcome.)*

#### **Direct method:**

1. **Graduate Critiques:** All M.F.A. students are required to participate in regular reviews critiquing their artworks. These reviews involve both a mid-term critique conducted by several faculty members and a final critique attended by the entire department faculty and all current M.F.A. students. After M.F.A. students receive Candidacy, their participation is still required although they will no longer need to present their artwork for review.
2. **Candidacy Application and Review:** After completion of at least two (2) semesters in the M.F.A. degree program, the student may make application to be a candidate for completion of the M.F.A. degree. The art faculty will conduct a formal review of the applicant's work and progress in the program. The awarding of candidacy will be dependent upon a two-thirds majority vote by the graduate faculty based on the following criteria: 1) a demonstrated formal and technical proficiency in the applicant's major studio area; 2) conceptual development as demonstrated by growth in ideas supporting the

applicant's creative research; 3) an ability to locate their research in the context of issues and practices within contemporary and historical art issues; and 4) the ability to communicate the intention and basis of their research in coherent written and verbal form. At least two (2) regular semesters of residence must be completed after acceptance as a degree candidate.

c. **Graduate Committee and Major Adviser:** When the student has been accepted as a degree candidate, the student will select a major adviser from the graduate art faculty. The major adviser will serve as adviser to the student in planning the completion of the program of study. At least one semester before graduation, a four- or five-member committee of graduate art faculty will be selected. The student's major adviser will be chairperson of this committee, and one member of the graduate committee will represent the art history or criticism area. The degree candidate may select one additional committee member from a discipline outside the Department of Art.

4. **Graduate Assistantship (GA) Supervisors:** Each GA is assigned to a supervisor who writes a duty sheet describing the assignment and distributes to the GA through the Graduate Coordinator along with the GA contract in the beginning of each semester. The Graduate Coordinator collects GA Evaluation sheets twice per semester at midterms and finals in order to assess performance in the GA Assignment area. Areas of assessment include: Being punctual and present for the duration of duties, quality of work performed, completing duties on time, and faculty prerogative on continuance in the assignment. If a GA receives one evaluation in which they are not meeting the expectations of the assignment, it will be met with a warning from the Graduate Coordinator. If a GA receives two consecutive evaluations from the same supervisor in which expectations of the assignment are still not being met, the MFA Student may lose their Graduate Assistantship per graduate faculty vote. A MFA Student may also lose their Graduate Assistantship at any time with 60-days' notice.

5. **In-Direct Method:**

MFA students are required to maintain a 2.85 or higher-grade point average overall or will be placed on academic probation. After two consecutive semesters on academic probation, the student may be dismissed from the program and will lose their Graduate Assistantship.

## **Annual Academic Assessment Report (MFA in Studio Art) (May 2024)**

Report annually to the Dean of the college/school the following: Results of analysis of assessment of Student Learning Outcome

1. On the Academic Progress forms submitted to the Graduate School annually, all thirty-one (32) MFAs made satisfactory progress towards completion of the MFA degree in Studio Art during the 2022-2023 academic year.
2. Twelve (12) MFAs successfully completed their MFA thesis exhibitions and submitted their final written thesis to the Graduate School with the approval of the thesis chairs and committees. Four (4) MFA students were “off cycle” and completed their MFA thesis exhibitions in Fall 2023. Six (6) MFA students successfully passed their full-faculty Candidacy Reviews on May 5, 2024, and received unanimous support from faculty. Two (2) second-year MFA student voluntarily withdrew the MFA program due to personal reasons. Twelve (12) first-year MFA Students received evaluation scores following midterm and final critiques with the faculty that met and exceeded the below areas as assessed by the majority of graduate faculty.
  1. Conceptual Development
  2. Technical Development
  3. Productivity
  4. Presentation
3. All thirty-one (32) graduate students received grades of As and Bs in Art Studio (major and studio electives) and Art History (including Contemporary Art History and Critical Theory) courses during the 2023-2024 year.
4. All thirty-two (32) Graduate Assistants (GAs) including TAs for our Foundation and Studio Courses met and/or exceeded their supervisors ‘expectations.

Any changes to degree/certificate planned or made based on the assessment and analysis – none.

Any changes to the assessment process made or planned.

1. The MFA Program Handbook was continually updated to include Studio specific information related to policies, procedures, resources, and instruction.
2. A summer faculty working group has been formed for Summer 2024 to continue reviewing specific areas of the MFA program. Critique structure, mentorship, and seminar structure revision are a few of the areas that are under review.
  1. As a result of summer 2023, the following are recommendations that were brought to the full faculty for vote and have been implemented.
    1. maximums for faculty members on quantities of independent studies, thesis committees, candidacy, and chair positions that they should agree too. 1<sup>st</sup> & 2<sup>nd</sup>.
    2. Adjust critique forms to exclude number system. Move to language-based assessment. Ex: “Meets Expectations for graduate-level work”, “Exceeds Expectations for graduate-level work”, etc.
    3. Set expectation that students hang work 1 week in advance so that faculty can review the work & writing ahead of critique.
    4. Hosted community events in fall 2023 & spring 2024 or receptions around MFA critiques to further appreciate the work.

5. beginning exploration of new critique structures – Jeff Kasper
  6. policies and procedures for Graduate Students transferring Areas.
2. For summer 2024
1. Prioritize and establishing a plan for which items to bring to faculty next.
  2. Mentorship Program for 1<sup>st</sup> year MFA students
  3. Possibilities for new curriculum – 2<sup>nd</sup> year seminar, Critique Seminar, Teaching Practices in Studio Art, etc.
  4. Standardizing curriculum for individual cohort seminars
  5. Establish a process for graduate students who are interested in Teaching positions to enter those roles with support
