Assessment of ARHS BA 2021-2022

1. Ability to identify major works of art and know their periods

Learning outcome #1 was assessed in ARHS 2913, Survey 1, taught fall 2021. Students were given three tests on which they had to identify works of art and their periods as well as write a brief essay on each artwork (1-2 paragraphs). The average grade on test 1 was 88.28. The average grade on test 2 (midterm exam) was 88.01. The average grade on test 3 (final exam) was 89.37. These grades demonstrate solid performance overall and represent improvement in this skill over the semester. This assessment was slightly stronger than results in the 2019-2020 assessment, indicating continued improvement in this skill among ARHS BA students.

2. Ability to do formal (stylistic) analysis of a work of art.

3. Ability to do iconographic analysis of a work of art.

Learning outcomes #2 and #3 were assessed in ARHS 4983, Special Topics in Art History (Golden Ages), taught spring 2022, through the third and final essay assignment. Using the ranking 4= excellent; 3= good; 2= fair; and 1= poor, the results for objective #2 (formal analysis) were six 4s, eight 3s, three 2s, and one 1. The average score was 3.05. The results for objective #3 (iconographic analysis) were five 4s, nine 3s, four 2s, and zero 1s. The average score was 3.05. The instructor was satisfied with these results, as few students were performing at the fair or poor level and most students achieved excellent or good marks on both goals. This reflects satisfactory ability in these two learning objectives and is consistent with results in the 2019-2020 assessment.

4. Ability to conduct research and write analytically about works of art.

Learning objective #4 was assessed in ARHS 4813, History of Photography, taught spring 2022, through a final research paper. Students wrote essays in which they examined original photographs held in Special Collections at UA or in area museums. The average grade on the paper was 87.04. The instructor was satisfied with student outcomes, and especially with students' ability to conduct research and write analytically about original primary objects; the results on this assignment indicate a high level of research skill overall.

5. Ability to speak analytically and present research results about works of art.

Learning objective #5 was assessed in ARHS 4933, Special Topics in Modern Art (The Art of Advertising), taught in spring 2022. Students had to give two oral presentations. The first was a concise "elevator-pitch" and the second was a final presentation measuring skill in persuasive communication. The average grade for the first presentation was A-/B+. The grade for the second presentation was an A. The results demonstrate strong performance overall and improvement in this skill over the semester. The instructor had students participate in a workshop through the Office of Entrepreneurship and Innovation at the Brewer Family Entrepreneurship Hub, which strengthened student outcomes.
