**Accreditation Standard 4.0.2: The program provides its most recent year of summary data and outcomes for the assessment of each of the identified competencies, specifying the percentage of students achieving program benchmarks for each program option.**

The table below is based on the assessment data collected in the 2021-2022 Academic Year for MSW Generalist and MSW Advanced Specialist students, as well as an aggregate of MSW students from all options. The percentage of students who achieve the Benchmark is inclusive of two measures: the Final Field Evaluation and the Assessment Survey.

Overall, 70% of MSW Generalist students achieved eight of the nine competency benchmarks; the percentage of students who achieved these eight ranged between 78.1 and 98.8%. However, MSW Generalist students did not meet the benchmark for Competency 9 (63.1%).

80% of MSW Advanced Specialist students achieved eight of the nine competency benchmarks; the percentage of students who achieved these eight ranged between 86.7 and 98.8%. However, MSW Advanced Specialist students did not meet the benchmark for Competency 1 (78.1%).

MSW students across all program options met all competency benchmarks at 80%.
